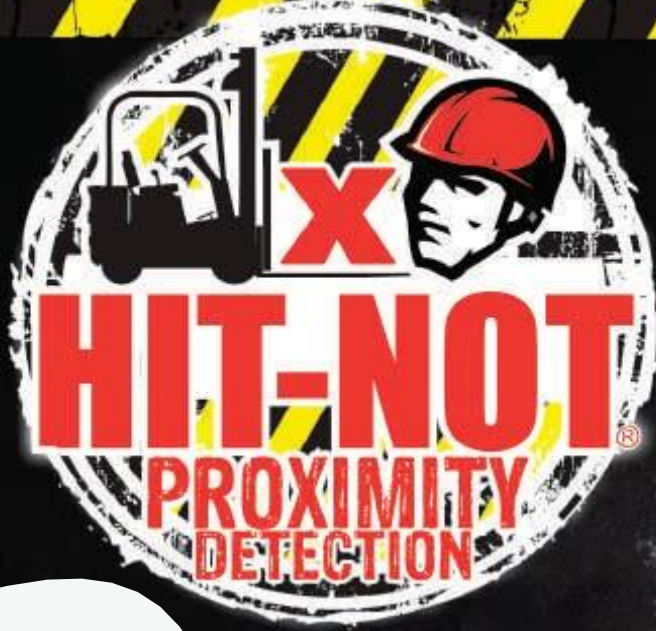

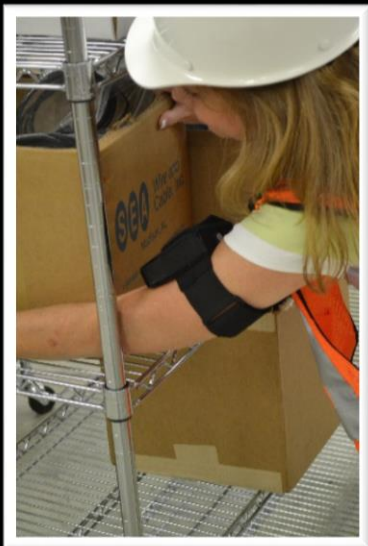

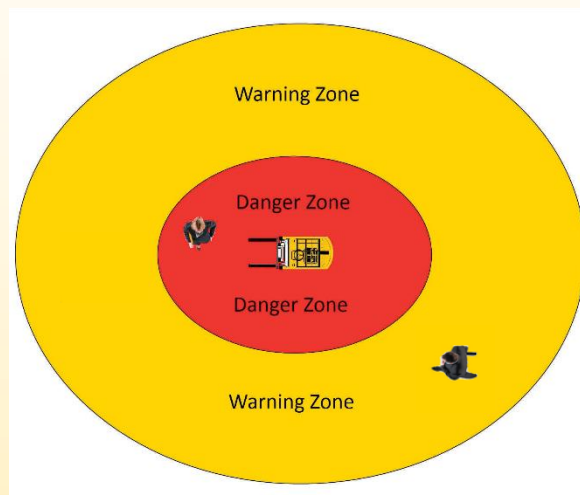


Originally developed for use in underground coal mines, this technology has been adapted and upgraded to essentially eliminate STRUCK-BY accidents in the forklift industry.

- Hard Hat Mounted



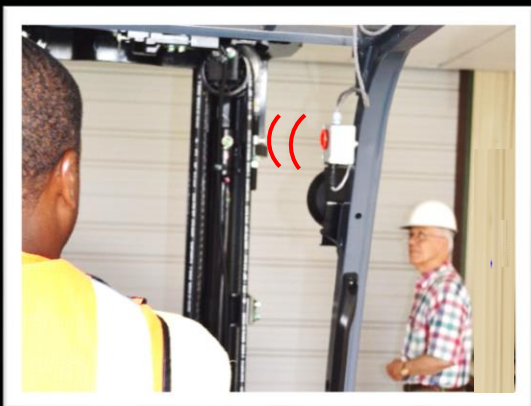

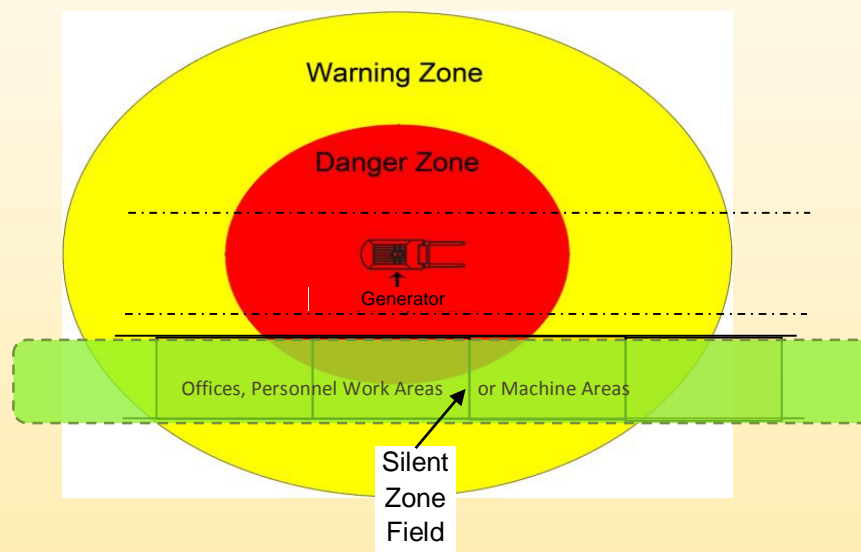

SILENT ZONES

Silent Zones are used to create areas where the warnings emitted by the Personal and Vehicle Alarm Devices are ignored. Silent Zones are standard on the vehicle for the Operator but can also be installed in locations where personnel are protected by walls and guard rails. Personnel in Offices and Machine Areas will not be distracted by the warning signals as vehicles drive by. Silent Zones can be Oval in shape up to 22 feet in diameter or Linear up to 250' in length.



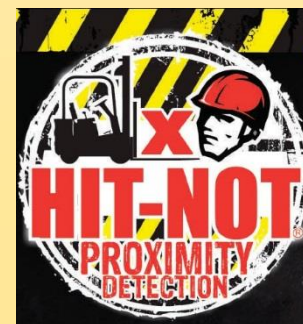
HIT-NOT® Magnetic Field Generator

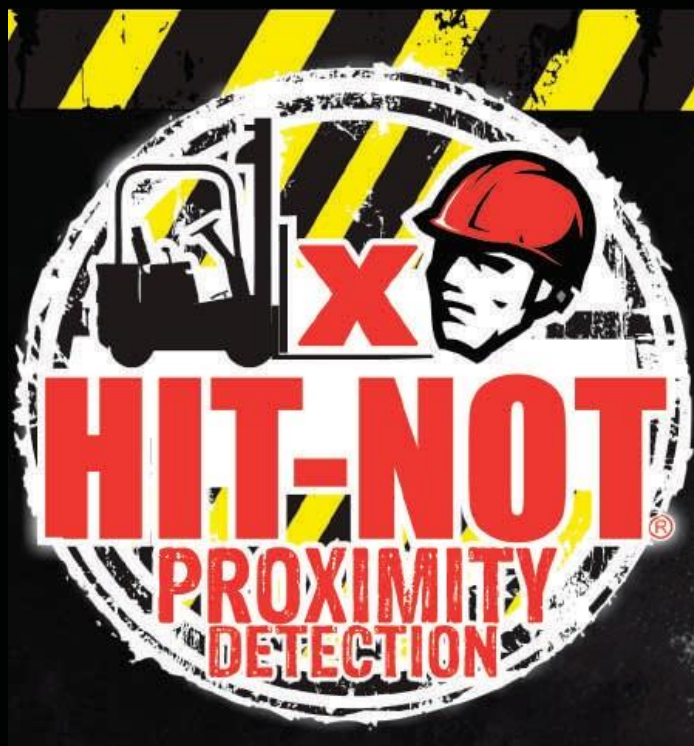

The key to the system is the Personal Alarm Device or PAD which is worn by personnel and vehicle Operators on either a vest, shirt or hard hat. The PAD gives both Audible and Visual LED Warnings when you are threatened. It also transmits a signal to the vehicle, to let the Operator know you are in danger. Both alarms will help to avoid a collision. There is no limit to the number of Forklifts, Personnel Carriers, AGVs, other vehicles or PADs which can be used at one time.
